The School District Meeting was called to order at 10:00 AM by Winston Chambers, Moderator, before Barbara Graham, Town Clerk read the warning, she thanked Winston for his several years of service as Moderator as this was his final meeting.

ART 1:

To elect all necessary Town School District officers for school Director for the ensuing year by Australian ballot. For the purpose of this article, the polls will be opened at 10:00 A.M. and closed at 7:00 P.M.

To see if the Town School District will authorize the Board of Directors to borrow money on the notes of the Town School District or otherwise, in anticipation of taxes.

The motion was made by Rama Schneider and seconded by Alvin Avery to approve the article as written There was no discussion and the motion passed by voice vote.

ART 3:

To see if the Town School District will vote to raise and appropriate the sum of \$4,000, to pay the School Directors, by Australian Ballot.

ART 4:

To vote by Australian ballot on the following: Shall the voters of the Williamstown School District approve the School board to expend \$8,134,722, which is the amount the school board has determined to be necessary for the ensuing fiscal year? This represents a (-10.14) % decrease from the previous year. It is estimated that this proposed budget, if approved, will result in education spending of \$14,809 per equalized pupil. This projected spending per equalized pupil is 6.62% higher than spending for the current year.

Freda Hollyer asked the school board to explain the decrease in percent on one line and increase in percent in another line and Rama Schneider explained due to the State wording requirements there was a decrease in local budget and increase to the Supervisory Union budget with overall a $2\frac{1}{2}$ % increase in the proposed budget.
