
**Old Business** – None


**Adjourn** - Francis made motion to adjourn 9:15 p.m. Scott Second. So moved.





Visit called to order 6:00 p.m.




Walked the road. All upgrades requested by Selectboard have been done.


Will need to trim a few trees back from the road so they do not hit dump truck.
