Fire Truck Accident: Truck totaled. William Graham, Fire Chief stated that 85% of all calls this truck was the first responder. This truck carried the Cascade system which is the only Mobile unit in the area that can fill the tanks a 100%. Mutual Aide Departments depended on this unit. There is \$290,000.00 in the Fire Truck Equipment replacement fund. The insurance is paying \$100,000.00

towards replacement. William and Jackie will look into options new vs. used trucks. Will have more information at the November 20th budget meeting.
