**Cemetery Budget:** John Perkins gave a brief update on what the Cemetery Commission has done in the past year. Researching missing stones and surveying and pinning new sections of cemetery.

**Town Clerk Pay:** Possible separate article for \$43,315.52.


**Policing:** Jackie to speak with Carl Rogers in regards to policing contract with Barre Town option.

**Fire Department Truck –**


Fire Chief and Town Manager have been working to find a used truck to replace the truck totaled in the accident on Pleasant Street. No used trucks out there that will work with the cascade system. Also searching for a possible demo that could cooperate the cascade system on to. Received \$99,000.00 from the insurance company for fire truck and have \$290,000.00 in the reserve account for a total of \$389,000.00. New truck would be anywhere from \$400,000.00 to \$450,000.00. Town Manager researched loans figures for 5, 6 and 7 year loans for \$250,000.00 and \$200,000.00 from the reserve account. Selectboard told Fire Chief and Town Manager to continue getting prices from three different companies.


