- Horace D. Should this area be expanded?

More discussion in regards to what area to cover.

Matt R. Our Solid Waste Ordinance applies to the whole town. Another suggestion - - we could call it "Down Town Property Standards".

More Discussion: Property needs to be kept in accordance with the Town's Solid Waste Ordinance and also with the Junkyard Ordinance, {which is being worked on at the present time also}. Under - "Housing" – Suitable 4 season permanent structure.

Jasmin C. We could consider saying - -

Although Williamstown is a farming community the DTA is not suitable for farm animals.

- "A" To include those farm animals for personal consumption.
- "B" To include those animals that are excessively loud and disruptive to the community.
- "D" Any livestock over 15 lbs.
