Possible add "animals should not be disruptive" to Dog Ordinance

Unoccupied buildings need to be safe – structures should be kept in accordance with Public Safety Standards. (Look at Montpelier & Barre "Safety Standards"

for examples)

Apartment buildings and multi-family dwellings should be kept in accordance

with State Standards for Multi-unit Housing – (plumbing, electrical & fire

standards).
