Matt R.	Suggested looking back at the Select Boards Minutes. We should look this over for any possible up-dates too. Could possibly use this to combine with a Downtown Ordinance.
	Looking at Bradford and Wallingford's Junk & Junk Vehicles Ordinance. They look close to the State Regulations.
Jasmin C.	We would have to add in some exceptions – for the Junk Ordinance – similar to Section F: Exceptions in the Solid Waste Ordinance.
