Working on a Vacant Building Ordinance and sample ones from Barre and Montpelier were passed out. Discussion followed and suggestions made to start writing one for Williamstown.

Horace D. Do we have the same authority – for a town - as the cities do in a state statute? Something to ask Jackie. If so, which one would we use to regulate this ordinance?

Discussion followed on wording to use – taking some from both the Barre & Montpelier sample ordinances. Once typed up - - give Horace a call so he can re-view for corrections and additions.

- Rich T. Looking at the Town of Williamstown's Outdoor Storage, Junk & Junk Vehicle Ordinance Dated Dec. 1, 1997 that was defeated at the Town Meeting in 1998.
- Jasmin C. Francis Covey and others thought that it was too restrictive.
- Rich T. We will look at working on a Junk Ordinance at the next meeting.
- Jasmin C. We the Select Board had been working on a Junk Car Ordinance in the last year. Look at the wording and see if we can use any of it. Check with Jackie for a copy.
- Rich T. Will also need to discuss Jackie's suggestion to do a separate Large and Small Animal Ordinance. Jackie suggested that the newest Dog Ordinance should not be changed since it was just adopted recently.
