Also, I want to bring it to your attention that the Village Cem. lot map needs to be corrected as the West Range Rows, #12 & #13 are not right. The lot sizes on the map are 20x20 but in row 12 they were sold as 5x5's and 5x10's. The lot in WR13 for Terry Knight is not correct – it

should be in Row 12. A corrected Deed will need to be done on this one.

Susan L. I will take care of doing a Corrected Deed.

I haven't heard anything from John P. regarding the invoice from Logan Clark and also about

getting another load of material for the lower driveway, but I can give him a call.

Will also check with John Perkins to see if they do have a large flag that we can have for the

Village Cemetery as he mentioned that they might have an extra one.

Orvil L. I spoke with Azea Pelkey regarding cemetery lettering and also about the fence in West Hill.

Asked Joe if he was aware that Joe's Custom Mfg. was recently bought out by B&B

Sandblasting in Barre.

Joe M. No I was not aware but will try and get in touch with them and also check around for pricing on

corner posts.

Susan L. Regarding the fence in the West Hill Cemetery - - I spoke with Tom Zampieri to see if he did

any mobile sandblasting and he said no – but he did give me a name to check with. It's Steve Davoll from Barre. I can give him a call and see if he's interested and get a price

quote.
