South Hill Road Repair - Three sealed bids were submitted to the Town Manager's office. S.D. Ireland Brothers, Inc., Ward's Excavation and Hebert Excavation.

Larry Hebert recused himself from the Selectboard as Hebert Excavation had submitted a bid.

Bids were opened in the following order:

S.D. Ireland Brothers, Inc. - \$319,100.00

Ward's Excavation - \$198,800.00

Hebert Excavation - \$141,540.00

Clayton made motion to accept Hebert Excavation bid of \$141,540.00 to repair South Hill Road. Scott second. All those in favor: Clayton Woodworth, Scott McCarthy and Chris Wade. Opposed: None. Recused: Larry Hebert. So moved.

Rodney Graham did ask if any help was being done for Covey farm flood damage. Larry stated that Ben Covey has been in the loop of all meetings with contractors and FEMA and is applying for help through Agriculture FEMA assistance for the damage to his pasture and that the town was supporting in anyway we can.

At this time Larry Hebert took over running the meeting.

Gilbert Road Culvert Purchase:

Contech Engineered Solutions submitted a price for an Aluminum Plate Structure 13' 1" x 8' 4" Rise X 81' Length. Cost \$57,321.00. Assembly \$23,866.00.

Scott made motion to purchase structure from Contech. Clayton second. All those in favor: Scott McCarthy, Chris Wade, Clayton Woodworth and Larry Hebert. Opposed: None. Motion passed.

Town Manager read the updated report on road repairs completed and pending from Flood damage.
