WATER TANK PROPERTY SOLAR PROJECT – Chris P. made the motion to deny supporting reapplying for the state permit. Chris W. seconded the motion. So moved.

OCSD CONTRACT APPROVAL – Chris P. made the motion to approve, Clayton seconded. During discussion, Chris P. requested to amend the contract to include some changes through the Town Manager. Chris W. requested more detailed Road Logs from OCSD. Chris P. made the motion to table the discussion until the requested changes were made. Clayton seconded.

BRUSH HILL BRIDGE – Discussion on pricing out Steel beams to repair the bridge to make it safe for traveling. Scott made the motion to price out steel beams to repair the bridge. Chris P. seconded the motion. So moved.

PURCHASING POLICY UPDATE – Jackie requested a higher budget for purchasing for the town. The request for the town as well as the bid process. Rodney Graham spoke regarding the state law that states how much is required to go out to bid. Chris P. asked to table the motion until it could be researched on amounts allowed. He stated that he would support doubling amounts if it is within the law. Clayton seconded. So moved.

Old Business:

HOYT-SEAVER FIELD DIAMOND – Request for FEMA to cover field/fence. Chris P. suggested to have the fence taken down and pay to have it done. Jude Horwitz offered to remove the damaged fence from the field. Chris Dessureau spoke regarding the brook with the silt behind the backstop being cleaned and cleared.

PAVILION RENTAL AGREEMENT- Chris P. asked to revise the agreement to be comparative to other local towns. Discussion was tabled until the agreement has been revised.

RECLASSIFICATION OF ROADS – FINDINGS OF FACT, CONCLUSSION OF LAW: MacDonald and Clark Roads will be on the September 11th Selectboard Meeting agenda.

WILLIAMSTOWN RECREATION BOARD – SIGNAGE: WRB requested to have the Williamstown Recreation Board logo on the Pavilion. After discussion, Chris W. made the motion to accept the request to put the WRB logo on the pavilion. Clayton seconded the motion. Chris P. recused himself.
