

BOARD OF ABATEMENT

FEBRUARY 27, 2024

The meeting was called to order at 6:33 P.M. by Elaine Owen

TOWN MANAGER'S REQUEST: Jackie Higgins, Town Manager/Delinquent Tax Collector requested an abatement of \$7594.93 for delinquent property taxes and water/sewer on property located at 46 Meadow Street, an unlanded mobile home owned by Tender Loving Homecare, LLC. This property was purchased in a tax sale, in April 2022 which was formerly owned by Rosignol Dery. On July 10, 2023 the mobile home was severely damaged by high water from the flood and became inhabitable. The water damage created a water leak under the mobile home which caused the large water/sewer bill. Tender Loving Homecare LLC is abandoning the mobile home, and the Town could tax sale it again. Jackie Higgins reached out to former owner Rosignol Dery to see if he would take the mobile home back if all delinquent taxes and water/sewer were abated since the mobile home sits on his property. Rosignol Dery agreed to that offer after speaking with his attorney and he would have the mobile home removed. The mobile home is still on the Grand List but has 0 value. Justin Ducey did question if we should get something in writing to that effect that he would have the mobile home removed. Jackie Higgins replied that would be possible. After a brief discussion, Gordon Murray made the motion and seconded by Will Knight, Jr. to abate \$7594.93 in delinquent taxes and water/sewer with conditions that the mobile home be removed on or before July 1, 2024. Motion passed by voice vote. Decision was based on Abatement #5 taxes upon real or personal property lost or destroyed during the tax year, 24 V.S.A. 1535

APPROVAL OF MAY 3, 2023 MINUTES: Orvil Lasell made the motion to approve the minutes as written and seconded by Elaine Owen. Motion passed.
