Barre Town EMS Report:

David Danforth, BTEMS Director updated that from January 1 to June 30th there were three hundred calls. This was a 45% increase over last year's calls. The average response time is 8 minutes 6 seconds. Just under 10% of the runs came from other stations. Barre Town passed their budget and there is a reduction to the Town of Williamstown per capita rate. Which is not \$65.00 per capita. This will reduce our budgeted costs to BTEMS by \$40,000.00. BTEMS will be showing off the newest ambulance purchased, which now has Williamstown name added to the town's serviced on the Ambulance.

Working through the Fire Department being toned out for accidents. Will need a letter of agreement between the town and VSP and possible OCSD to get the Fire Department toned out for all accidents. Selectboard is in favor of moving forward with the process. The concern was brought up to not let the cost become a burden to the taxpayers. Willam stated that the insurance billing was taking care of most of the cost. Will work up an agreement and bring back to the board for review.
