Dave T.	I went to the Chelsea Planning Cmsn. meeting. It was their 2 <sup>nd</sup> formal hearing on their Town Plan. They were surprised to see me. No one had come to their first meeting. They did have two people from Twin River Regional Planning Cmsn. who were overseeing the meeting. I asked them what some of their difficulties were. They said one was the Wildlife corridors and the other was regarding Energy. Having the State mandates to adhere to was difficult. The State wants everyone to buckle down on clean energy. They are a small town. Something that they are stating is "Energy savings are not always possible for lower income residents." (This is a great statement and the discussion was from our group to incorporate this in our Town Plan's energy section.)  We spoke on flood control and flood resiliency they had no answers to this. They have Main Street flooding also – it's on-going. No plans to address this.  I did ask if they had talked to the Army Corp. of Engineers. No response.  They also deal with the towns of Washington and Tunbridge with flooding issues, who are also small towns. They are still waiting for FEMA monies from last year and this year.
